1. *Whereas the rates of Bricks were fixed @ Rs. 4000/= A-Class and @ Rs. 3000/= B-Class vide this office order No DCA/Accts/11-12/227-36 dated 18-05-2011 excluding freight charges in District Anantnag.*
2. *Whereas, the matter was agitated by the Brick Kiln owners time and again before this office for reviewing the rates of Bricks.*
3. *Whereas, in order to review the rates for Bricks in District Anantnag a committee of experts of various Departments was constituted vide this office order No DCA/Accts/11-12/910-13 dated 05-08-2011 in order to get a technical report of analysis for manufacture of bricks.*
4. *Whereas, the committee after making analysis for manufacture of Bricks furnished a detailed report regarding rates of burnt bricks in District Anantnag as under:*
  - i) *A-Class Rs. 4200/= for one thousand. Excluding Transportation charges*
  - ii) *B-Class Rs. 3000/= for one thousand. -do-*
5. *Whereas the committee conducted a meeting on 23-08-2011 in order to review the rates of Bricks in this District.*
6. *Whereas, Brick Kiln owners approached Deputy Commissioner and requested that before finalizing the rates, they be heard again;*
7. *Whereas, a joint meeting of expert committee consisting of General Manager DIC, Assistant Commissioner Labours, Assistant Executive Engineer R&B Division, Assistant Executive Engineer Mechanical Division Anantnag and Brick Kiln owners was held on 25-08-2011, wherein thread bear discussions were held. The expert committee after taking into consideration the arguments put forth by Brick Kiln owners felt that there is no reason to change, modify or reconsider the report filed by them earlier.*

Now therefore, keeping in view the report furnished by the Committee and also the arguments put forth by Brick Kiln owners, the rates of bricks are fixed as follows under Section 13 of Brick Kilns Regulation Act read with SRO 93 dated 23-03-2011.

- i) A-Class Rs. 4500/= for one thousand. Excluding Transportation charges
- ii) B-Class Rs. 3000/= for one thousand. -do-

(The Assistant Road Transport officer Anantnag is directed to fix the <sup>Destination</sup> District wise rates for transportation on or before 05-09-2011 and shall give wide publicity to transport charges).

This order shall come to in force with immediate effect.
